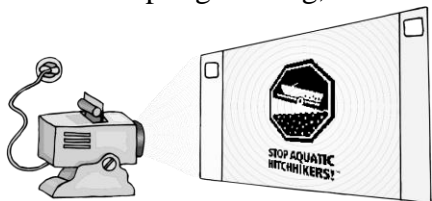

Shoreland restoration applications being accepted

Postcards and emails were sent to Lake Shamineau Association members last month letting them know that they could begin to apply for grant money to do shoreland restorations or buffer zone improvement projects. The purpose of this project is to help maintain the water quality of Lake Shamineau through natural shoreline restoration and promotion of native species to help prevent the invasion of exotic species.

Each project would be funded up to \$1500 split equally between the property owner, the Lake Association and the Initiative Foundation. The property owners' share can be in-kind labor, so there is the possibility of no out of pocket expenses for property owners.

All applicants for this grant must be members of the Association. 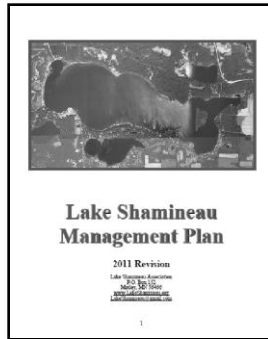

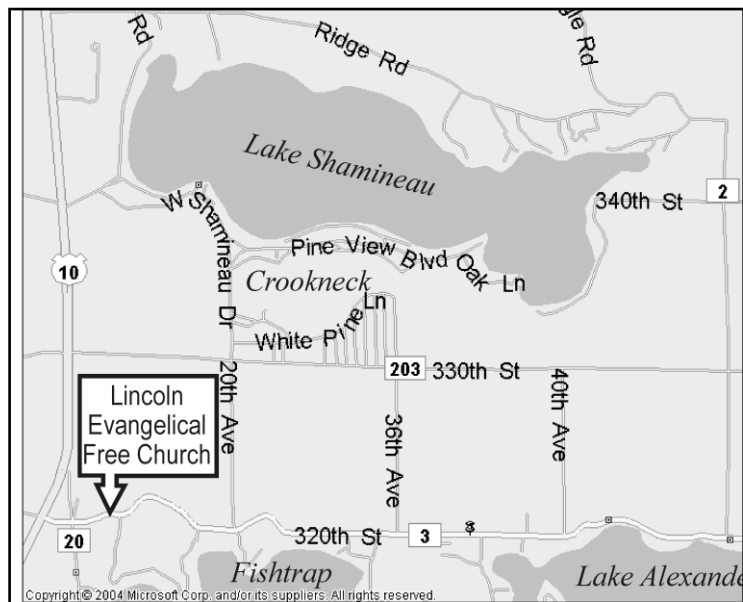


Lake Management Plan updated

Spring Membership Meeting Minutes

September 4, 2010 9 a.m.

President's Welcome

President Jennifer Buckentine called the meeting to order and welcomed the members to the spring meeting. Board members introduced themselves. Jennifer expressed thanks to the church for the meeting space and coffee provided and to Jacquie Rognli for her preparation for the Lake Plan visioning session planned for this meeting.

Open Forum

Began the meeting with questions or issues that membership wished to raise. Members are interested in the access at the east end of the lake – the need for concrete slats in the water to prevent large holes in the lake bottom. Al Doree attends the township meetings and will inquiry about what can be done.

There was a question about the water level in the lake and whether the culverts were open and if beaver activity was affecting lake level. It was noted that rainfall had been consistent during the summer and it was not a very dry year.

Approval of Spring 2010 Membership Meeting Minutes

The minutes from the Spring 2010 membership meeting were printed in the August 2010 newsletter. A motion was made to approve the minutes. The motion was seconded and approved.

Treasurer's Report

Pat Held, Treasurer, provided the following balances in the Association's bank account at Randall State Bank:

Income includes membership dues and ads for the newsletter. Expenses include postage, water quality testing, membership signs and year tabs, meeting expenses (coffee, donuts, prizes).

Lake Plan Visioning

Ideas and goals were solicited from the members, working in groups, and were written on large sheets of paper with the topics of Location, Family Friends & Neighbors, Water, Wildlife & Fisheries, Land.

Volunteers were identified who would participate in an upcoming meeting to update the Lake Plan goals and methods of attaining and measuring the goals. Video "The Living Shore" was shared.

Committee Reports:

Fishing

Rick Rosar reported that a net survey had been done in the past month and results were not yet available.

Water Quality

Al Doree showed up to date graphs of lake level, rainfall, water temperature, dissolved oxygen, and demonstrated the RMB website where the data is tracked. The results show excellent water clarity and a stable trophic state index (indicator of biomass/plant growth in the lake).

Membership


Carolyn Held reported that currently there are 207, some new and some members yet to be contacted. Carolyn recognized all of the volunteers who help with making contacts with lake property owners to encourage membership.

Other Business

The Lakeshore Improvement Grant application was being completed. It is a \$15,000 project that runs to December 2011. Up to \$5,000 is provided by the grant, with matching dollars from the Lake Association and matching value from the landowner. Landowner matching funds can be in kind, for instance providing the labor for planting and restoration. The Association is developing an application for landowners to apply in the spring.

Herb Bloomquist of Camp Shamineau encouraged people to use the island, clean up if camping overnight and let the camp know if they plan to be there. He also encouraged volunteers interested in building a shelter on the island at the old fireplace. There is a golf tournament for the camp on September 17.

Tax - 6.875% + .50% local sales tax = 7.375% for a total tax of \$139.98

Total Cost = \$2037.98

This includes the cost of 31 planks, all necessary hardware, clips, taxes and delivery to the Lake Shamineau East boat landing.

The Scandia Valley Township has agreed to pay for the installation per DNR specs which will include 12 to 15 yards of sewer rock and 10 to 12 yards of Class Five material and maintain as required.

Because the Lake Association is buying the planks instead of the DNR donating them, the township is not required to take out a permit nor sign a 20 year maintenance agreement with the DNR.

Membership Report

Carolyn provided the count of current members (220). Discussion of what to publish in the newsletter to remind people of when their membership expires to help with renewals and decreasing the number who need to be contacted in person at their cabins in the summer. The due dates will be listed in the newsletter, as approved by the board. The board also approved of the expense to purchase new year numbers for membership signs.

Fishing Report

Rick provided the report on the 2008 DNR report on the stocking of muskies and its impact on other species in Minnesota lakes for board discussion.

Water Quality

We will not receive grant money this year as we have recently to cover the water quality testing. It costs approximately \$200 per year. Motion was made and approved to continue water quality testing at our expense. Average ice out is April 19. We would like to get dates for whole lake ice-over in the fall if any members have this information. Lake aquatic survey. Al will look into grants that may be available for the survey to update it from last time it was done by the DNR.

Communication

Discussion of moving the Association website to the Minnesota Lakes location and rebuilding it. Jacquie, Rick and Sandy will look at options and cost. Current website has no cost. Sandy is ready to pass the website maintenance to someone new – looking for a volunteer.

East End Lake Public Access Improvement

The concrete planks that go into the water to create the ramp have been delivered and paid for. The township will pay for installation this spring and will have the work done by a DNR crew familiar with this installation process.

Lakeshore Restoration Grant

Pat is developing an application form for members who wish to do native plant landscaping and shoreline protection on their lakeshore property. It was suggested that we send a postcard to lakeshore owners

to respond if interested in getting an application form. An approval committee will meet May 28 for the first round of approvals. Application approvals will depend on appropriate restoration plans and will be prioritized by first applications received. Funding will include equal amounts of up to \$500 from the grant, plus \$500 from the Association, and \$500 in-kind from the applicant (in-kind can be labor). Smaller amounts may be applied for also and number of grantees depend on size of requests. The grant received is \$5,000. An online presentation about lakeshore restoration is located at:

Loon Report

We are Jim and Jill Pundsack from Sauk Rapids, MN. We are volunteers with the Minnesota LoonWatch program through the Minnesota Department of Natural Resources. We are among the 300-plus loon watchers who observe and report loon activity on 360 lakes in 35 Counties of Minnesota. We are the official Loon Watchers on Lake Shamineau. We have a camper at Augers Resort and have been there for 10 years.

In 2010, the number of loons counted on the lakes in Morrison County combined was 29 adults, 12 pair that



In 2010, Shamineau had 7 nesting pairs; 15 adults; 8 chicks. Alexander had 4 nesting pairs; 10 adults; 5 chicks. Crookneck had 1 nesting pair; 2 adults; 2 chicks.

nested and 15 chicks that survived into the fall. Other lakes in Morrison County that “loon watch” are Alexander, Crookneck and Sullivan. The “loon watch” count for the state of Minnesota (373 lakes in 32 counties) have reported 1713 adult loons and 459 chicks. Our task is to observe, count and record the nesting sites and the loons. At the end of the season, we report our findings to Pam Perry, the Minnesota Loon Watcher coordinator with the DNR. We are also instructed yearly when the DNR wants us to keep a look out for other birds, such as Pelicans, Purple Martins and the Red-necked Grebe.

We have clear direction from the Minnesota LoonWatch coordinator, about loon preservation, safety and protection. For example, we watch from a safe distance- at least 200 feet away so we have invested in 2 pair of good binoculars. Did you know that although loons are not considered a threatened species, they are protected from harassment by the Migratory Bird Treaty Act?

We begin our observation in early May by carefully locating the nest locations and report this to the DNR. Knowing where the nests are located can be valuable information for protecting the loons. Development projects, shoreline modifications, and aquatic vegetation removal can all threaten loon nests. Therefore, projects can often be modified if it is known that they would impact a loon nesting area.

After the chicks hatch (late June to early July), we count the loons and continue our observation of behavior and survival. This is the most accurate time

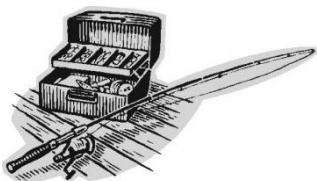
to count the loons because during this time, loon chicks are still small and stay close to their parents. It is easy to count family groups and number of chicks. We report anything unusual immediately to the DNR, otherwise, we just keep a record of what we see and send that into the DNR in September.

At the end of July, counting becomes inaccurate because the chicks are more independent and the parents are often separated from the chicks. Also, other loons visit the lake. You may have witnessed a group of 10 or more loons together bobbing and splashing and making lots of noise. Some of these loons are “visitors” and will stay for an hour or a couple of weeks. So we just observe and record activity at this time.

The DNR is diligently studying the Gulf Oil spill’s effect on Minnesota loons. We are all anxiously waiting to see how many loons return to Minnesota in April and what impact the oil spill may have had on the loons. So, all of the Loon Watchers will be observing much closer this year, paying particular attention for any signs of toxicity to the loons and their offspring and communicating carefully to the DNR.

We look forward to spring to arrive so we once again can observe these historic birds! They have taught us so much about patience and perseverance. We have so much admiration for the loon!

If you see any unusual loon behavior or distress, please contact the DNR or the Official Loon Watcher on your lake. 🐾



Fish Community Responses to the Introduction of Muskellunge in Minnesota Lakes (A summary)

Abstract—We (MN-DNR) evaluated responses of seven fish species to muskellunge by comparing each *catch per unit effort* (CPUE) before and after muskellunge were stocked in 41 Minnesota lakes composed of 12 lake classes. The species examined were northern pike, walleye, yellow perch, bluegill, black crappie, white sucker and tullibee. We found no significant decreases in mean CPUE among the lakes for any species after muskellunge stocking, either for stocked lakes as a whole or within lake classes.

The lack of consistent negative changes in mean CPUE after stocking suggests these fish species have

generally coexisted well with muskellunge in these lakes at the densities that have resulted from stocking.

Results

- For northern pike, there was no significant change in CPUE following muskellunge stocking within lake classes or for all MS (muskellunge) stocked lakes.
- Mean walleye CPUE was not significantly different overall for the MS-stocked lakes or for pooled lake classes.

- Mean CPUE of yellow perch increased in three lakes with no significant difference for the pooled MS-stocked lakes or lake classes.
- Following muskellunge stocking, bluegill trap net CPUE significantly increased for the entire group of 41 lakes...
- Relative abundance of black crappies was measured using gill nets and trap nets. Mean CPUE was not significantly different...for all 41 lakes.

Discussion and Management Implications

Our (MN-DNR) results indicate that fish communities in lakes actively managed for muskellunge in Minnesota continue to do well...The lack of consistent declines in CPUE for any species over the group of MS-stocked lakes suggests these fish species have generally co-existed well with introduced muskellunge...MS-stocked lakes maintained similar abundance levels relative to non-stocked lakes.

Many factors besides muskellunge have influenced fish communities and abundances in these lakes. Changes in fishing pressure, angler knowledge, and fishing technology along with changes to the lake environment including habitat, productivity, and climate have all played a role in shaping the fish communities that exist today.

Walleye and muskellunge management do not appear to be in conflict...suggesting that direct competition or predation was unlikely between the two species. The study found no significant difference in walleye CPUE following muskellunge stocking over the group of 41 lakes.

This is the most comprehensive study regarding muskellunge stocking in Minnesota. The Brainerd Area Fisheries, Grand Rapids Area Fisheries and the Fisheries Research group utilized data and research materials from 1945 thru March 2008. The entire report can be found online here:

East Landing improvements



The Lake Shamineau Association has partnered with Scandia Valley Township to install horizontal concrete planks at the public access at the east end of the lake. The planks will provide a firm base for vehicles and trailers launching boats. It is hoped that this will stop the bottom erosion that takes place when boat owners need to rev their engines to make it onto their trailer.

The Association paid \$2,038 for the cost of 31 planks all necessary hardware and delivery. Scandia Valley Township has agreed to pay for the installation per DNR specs which will include 12 to 15 yards of sewer rock and 10 to 12 yards of Class Five material and maintain the landing as required.

Once available as a purchased computer program, it has been converted into an informative interactive website from the Minnesota Department of Natural Resources.

Score Your Shore

Score Your Shore is a tool to assess habitat conditions of developed lake lots. The protocol is designed for use by lakeshore property owners to self-assess habitat and stewardship on their land and adjacent aquatic areas. Score Your Shore provides an objective and systematic method to assess the type, quantity and quality of the existing shoreland habitat.

The *Score Your Shore* tool will enable you to:

- Assess the amount of habitat at developed lake sites
- Generate awareness of what makes a high quality functioning shoreline buffer
- Provide a system to recognize landowners with functioning shoreline buffers.

Free documents can be downloaded from www.dnr.state.mn.us/scoreyourshore that will aid land owners in doing a 10-15 minute assessment of their property. A limited number of copies of the four-page score sheets will be available at the Spring Membership meeting, May 28th. 🐾

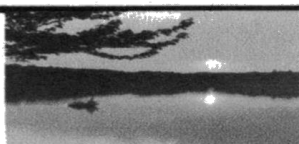
