## Summer Employment Opportunity

The Lake Shamineau LID is looking for folks who enjoy working outside!

Earn \$20/hour for sitting in the shade (or sun) at the lake. As a Minnesota DNR AIS Ambassador, you will be working at a public DNR or Township Access on Lake Shamineau. You do not need to be a resident of the lake, anyone that qualifies may apply. Additional “End of the Season Incentive Pay” may apply for hours worked if acceptable attendance of scheduled hours for the entire contract period. Requirements: Applicants must be at least 18 years of age and must attend a paid 3 hour AIS (Aquatic Invasive Species) training, in person or online with a DNR Regional Watercraft Inspection Supervisor. Must submit a completed DNR background check form.

Duties include greeting visitors at the public accesses on Lake Shamineau. Informing boaters about the “Clean-Drain-Dry” program for Aquatic Invasive Species, when their watercraft are entering and exiting our lake. Handing out relevant brochures. Answering boater questions about the AIS program. Documenting the number of watercraft interacted with and violations observed. (This is not an enforcement position; it is simply educational)

The program runs from May 15th (Opening Fishing) through September 4th (Labor Day), typically 4-6 hour shifts on Fridays, Saturdays, Sundays, and Holidays.

## Floating Bog Permit available to members

Lake Shamineau Association members are able to utilize the Association's DNR 2024 Bog Mitigation Permit to remove floating cattail bogs less than 6 x 6 feet in size and relocate larger bogs by reattaching them and securing them to land. Non-members would need to apply for their own permit from the DNR. 🐾

### Authorized Control Area:

Migrating floating bog(s) on Shamineau (49012700).

Migrating free-floating cattail bogs within Shamineau Lake may be removed if they are < or = to approx. 6X6 feet in size and larger migrating free-floating bogs may be moved and reattached in the SE bay area adjacent to state land or the NW bay area as long as they are not reattached in an area adjacent to private property and blocking their access to the lake. Work is to be done by association members only as they occur during the 2024 open water season.

### Authorized Action:

#### Relocating and/or removing of migrating floating bogs.

Relocated migrating bogs must be secured to prevent further movement using wooden stakes. This permit authorizes the transport of aquatic plants and prohibited invasive species during bog relocation or removal activities.

Before transporting the bog for disposal you must: (1) drain excess water from the bog material before leaving the water body, for example by parking the truck on an incline; (2) transport the bog material directly from the water body to the disposal site; (3) dispose of bog material at least 300 feet from any waters of the state or seasonally flooded lands; and (4) clean all aquatic plants, sediment and prohibited invasive species from all equipment with each load – no vegetation should be on the outside of the transport truck/trailer before using public roads. If you intend to remove the floating bog via a public access, make sure you contact the owner of the access (an access permit may be necessary).

The use of any heavy equipment (e.g. backhoe or bobcat) is not allowed to remove floating cattail bog under this permit and no removal of the lake bottom is allowed under this permit. DNR APM staff in Little Falls (320-232-1079) must be notified before large bogs greater than 50X50' in size are moved. Bogs must be inspected by permit holder prior to removal for presence of loon nests.

## Lake Shamineau Association to Provide Matching Grants

The LSA board of directors is establishing a grant fund for **shoreline plantings to stabilize the shoreline**. Grants are for a 50% match up to \$100 for plantings for shoreline improvement. The total funding available would be up to \$2,500. Criteria to receive up to \$100 are being developed and will be included in a form to apply for the match.

The board has also approved reinstatement of **the septic inspection program** for matching reimbursement with a total fund available of \$2,000. Upon presenting a paid invoice and filling out a short application, the applicant will be reimbursed for any amount up to \$200.

## Volunteers Needed – LSA Lake Monitor

With more than 92,000 miles of streams and over 12,000 lakes in Minnesota, the Minnesota Pollution Control Agency (MPCA) [Volunteer Water Monitoring Program](#) is gearing up for the 51st season of lake and stream water clarity monitoring across the state. Samples are drawn 4 times each summer and sent in for lab analysis. Secchi disk readings are taken to measure water clarity.

Water clarity is an important indicator of lake and stream health; it shows the amount of light penetration into the water. For streams, a low clarity reading reflects excess sediment. For lakes, it's excess algae. These conditions can affect plant, insect, and fish communities and impact recreational opportunities. The MPCA uses volunteer-collected data to detect trends in water clarity over time. Increases or decreases in water clarity may indicate changes in water quality on a lake or stream and formally assess the health of lakes and streams by comparing them to state water quality standards. Lakes and streams that fail to meet water quality standards are categorized as impaired and require restoration to improve their overall health

At least twice a month during the summer, volunteers measure water clarity using a Secchi disk or tube at designated locations on lakes or streams. During each visit, they record their reading and observations on the physical and recreational conditions of their lake or stream. They submit the information at the end of each monitoring season. Anyone can do it — no prior experience is needed. The MPCA uses volunteer-collected data to make decisions on watershed protection and restoration.

Lake Shamineau has been reporting this information by Al Doree since 2004. We need someone to carry on this important work. Please contact Bob Ingle or Dale Williams if you can help. 🐾

## Zebra Mussel Monitoring Program – MN DNR

Zebra mussels are spreading to lakes and rivers in the Midwest. These small invasive mussels attach to hard surfaces in lakes and rivers killing native mussels, limiting recreational activities, clogging water supply pipes, and competing with larval fish for food. You can provide important help tracking their distribution in Minnesota by spending a few minutes monitoring the lake or river where you live without any specialized equipment. Early detection for zebra mussels is important in protecting your property and Minnesota's water resources.

**How can you monitor for zebra mussels? In the late summer or fall when removing equipment from the lake:**



1. Visually inspect hard surfaces for zebra mussels such as docks, dock floats and supports, swimming platforms, boats, motors, anchors, and any objects that have been in the lake or river for the summer. Check areas where zebra mussels may be attached, such as trim tabs, rubber gaskets, grooves along the keel of pontoon boats, and sailboat centerboards. During early infestations, zebra mussels are likely to be small (1/4-1/2 inch long) and the number attached on any object is likely to be low. You can also examine rocks and other hard surfaces along the shoreline and in shallow water, especially near water accesses.

2. Complete and send in a [online Volunteer Monitor Report Form](#) by November 1st each year. Send in the report whether or not you found zebra mussels.

### What else can you do? (optional activities):

Make your own monitoring device. Hang a PVC pipe, brick or cinder block under a shady spot of your dock (zebra mussels tend to avoid direct sunlight) in the summer to monitor for zebra mussels. Suspend the object as deep as possible at the end of your dock, keeping it at least one foot above the bottom. Examine the monitoring object, and add these observations to the Volunteer Monitor Report Form. 🐾

The floodplain elevation is expected to be at 1280.16 and lowest floor will need to be above 1280.2 to be above the floodplain. Final maps are expected to be in effect later in 2024. **Take a Kid Fishing-** The Staples Sportsmen’s Club sponsors a Fishing Day for the Staples/Motley fourth graders. They purchase fishing rods for each child and supply the bait. The Staples Lions Club sponsors a lunch for the kids after fishing. The event will be held at Camp Shamineau on Friday May 17 from 9 am to noon. They are asking for volunteers with boats or pontoons to come to the camp at 9 am.

**Water Quality Testing Volunteer Needed** - The job consists of measuring water clarity with a Secchi disk and measuring the water temperature at various depths (thermocline). Also, a sample kit from RMB labs with a sample bottle is sent to RMB labs from measurements taken the third Monday of each month. Information will be provided in the Spring Newsletter.

**Septic System Inspection Grants** – An LSA member asked about the grants that were offered in 2019 and later suspended due to Covid. We need to decide whether to reinstate the grant program and how much to allocate. Sandy will send the board members information from the 2019 program.

**Spring Newsletter topics** – Ideas include information about the county tree sales program for 2025, shoreline tree and shrub recommendations, what value the lake association provides to its members.

**Annual Membership meeting** – We will look for a speaker on shoreline improvement and demonstrate how and where to find lake water quality on the web. Door prizes need to be solicited.

## Resilient Shorelines Workshop Thursday, May 16, 5:30 – 8:30 pm




